NON-PUBLIC HEARING – FP-2023-06: Application for a Final Plat for Autumn Ridge 5th Plat, a 57-lot-singlefamily subdivision, located west of Autumn Ridge 4th Plat and east of Emerson Park 2nd Plat. (Presented by Matt Wright, Community Development Director)

Mr. Wright, Community Development Director, gave an overview of the staff report.

Mayor Larkey, Sr. made a motion to approve the application for a Final Plat for Autumn Ridge 5th Plat, a 57-lot-single-family subdivision, located west of Autumn Ridge 4th Plat and east of Emerson Park 2nd Plat.
