- *You may plead not guilty by calling the court prior to your court date or appearing in court and requesting a trial date.
- *You may plead guilty by mail, internet/web or coming to the court to pay your fine.
- *If you plead guilty, but do not have funds to pay, you still must come to court. You will not be arrested for not having money to pay, unless in violation of any probation term.
- *If you do not come to court when summoned to do so, you are subject to a warrant
